Information note 22/7 of the Commissariat aux Assurances on the implementation of restrictive measures in financial matters and the data required within the framework of the "Quarterly report on frozen funds".

As a reminder, the Minister of Finance deals with all matters relating to the implementation of financial restrictive measures taken against states, natural or legal persons, entities or groups, as well as those obliged to apply them.

All natural and legal persons subject to the supervision of the CAA are required to inform the Ministry of Finance without delay of the implementation of any financial restrictive measure taken against a state, persons, entities and groups using the template of the "Quarterly Report of Frozen Funds" (link here) by e-mail to: sanctions@fi.etat.lu with a copy to the CAA address: lbcft@caa.lu.

For the sake of operational efficiency, the annexe provides the descriptions of the fields of the "Quarterly Report of Frozen Funds" from an insurance perspective.

It is important to note that restrictive measures in financial matters apply to states, natural and legal persons, entities or groups included in a list annexed to an act of the European Union, the United Nations or a Grand Ducal regulation ("reference lists").

Any declaration concerning the implementation of restrictive measures in financial matters that would be taken by virtue of another list, in particular in the context of activities carried out by branches of the operator, should be adapted in the event that the state, person, entity or group concerned appears a posteriori on one of the reference lists.
